**Snow Plowing:** This service is billed hourly (in ¼ hour increments), by the push (residential only - determined by size of driveway), or by negotiated monthly/seasonal rate. All rates include CBJ Sales Tax. Services will begin once snowfall has reached an accumulation of 2.5" or as specified below and will continue until areas are cleared to industry standards. Snow will be pushed to a designated location on property. Monthly contracts will be due on the 1st of the month. Season contracts are due at signing. Customers outside Main Area of Operation (See pg. 2, #8) agree to a fuel surcharge of \$10.00 per site visit when no other services are performed.

**Sanding:** Service is available on a contracted or on call basis. All parking areas such as entrances and exits, aisles, and parking spaces will be sanded in a timely manner. There is a ¼-ton minimum (can cover up to 800 ft²).

- Contracted, \$30.00 per ¼-ton
- On Call, \$35.00 per ¼-ton

**Shoveling:** Entryways will be shoveled once the snowfall has reached an accumulation of 2.5" unless otherwise specified by customer. All sidewalks, entryways, and exits will be cleared of snow and ice melt will be applied. Ice melt will be provided by Cross Island Snow Plowing at a per pound rate. This service is billed hourly, with a ¼ hour minimum.

- Sidewalks, \$60.00 per hour
- Ice Melt, \$2.00 per pound

**Snow Removal:** Loader and dump trucks will remove snow once snow storage is full. Cross Island Snow Plowing will contact Customer once service is recommended. Service is billed at an hourly rate, plus dump fees.

- Loader \$250.00 per hour, Dump Truck \$150.00 per hour, Dump Fee \$100.00 per load



## Snow Plowing Estimate / Contract

### Terms and Conditions:

1. This contract between Cross Island Snow Plowing and \_\_\_\_\_ (hereinafter "Customer") is valid from October 31st, 2016 through April 1st, 2017. This contract for winter services will be billed on the 1st of every month. Payments shall be due 30 days from the billing date. Payments may be made by check, credit card, or cash. Either party may terminate the contract for any reason by providing 7 days advance written notice to the other party. Upon such termination, services shall still be provided until the end of the 7-day period.
2. Accounts not paid within 30 days of the date of invoice are subject to a 1% monthly finance charge, and for each subsequent 30-day period of non-payment. The Customer agrees and understands that they will be responsible for all costs of collection, including reasonable attorney fees, should Cross Island Snow Plowing refer the Customer's account to a collection company or attorney for collection. The Customer shall be responsible for a \$30.00 returned check fee, or the highest amount authorized by law, for any checks returned unpaid for any reason.
3. This Agreement, including any attachments or exhibits hereto, and applicable license agreements, embody the complete and exclusive agreement of the parties and supersede all other communications, oral or written, between the parties relating to the Agreement's subject matter. Any change to this Agreement must be in writing and signed by both parties. Neither the failure nor any delay to exercise a right, remedy or privilege under this Agreement shall be operated as this Agreement is invalid, illegal or unenforceable shall not affect the enforceability of any other provision.
4. The services hereunder shall be completed in an industry standard schedule. Cross Island Snow Plowing shall not be responsible for lost work time on account of weather, strikes, terrorism, accidents, acts of god, or other events not in the control of Cross Island Snow Plowing. Cross Island Snow Plowing is not responsible for damages to landscaping, pavement, and grass on the Customer's property. The work herein may cause damage to the Customer's property.
5. The customer is responsible for boundary markers or flags, marking driveway edges, flower boxes, lawns, and other obstructions or property that could result in damage to customer or Cross Island Snow Plowing property. Cross Island Snow Plowing can provide these flags for a nominal charge. Cross Island Snow Plowing will not plow within 3 feet from any parked vehicles, equipment or other obstructions in parking lots, driveway, or other area being cleared. Please attempt to move obstructions prior to services being completed. Cross Island Snow Plowing is not liable for any damage to pavement, concrete, or other surfaces contracted for plowing of snow. Damage can occur but every effort will be made to avoid this.
6. Cross Island Snow Plowing shall carry all required insurance on its workman and equipment.
7. If the Customer requests any work above and beyond the work specified herein, the Customer shall be responsible for those costs on a time and material basis.
8. Main Area of Operation encompasses Mendenhall Valley, Lemon Creek, Downtown, West Juneau/South Douglas and areas in between. For all other areas not specifically listed, please contact us.

**Cross Island Snow Plowing and Customer have agreed that from October 31st, 2016 through April 1st, 2017 both parties will be under contract and all terms and conditions will be upheld. All changes to description of work or contract terms will be in writing and signed by all parties involved. By checking next to the above services, I accept this document as my contract for the winter season. The contract may be cancelled at any time with seven days prior written notice.**
